



DESCRIPTION OF STRATEGY

Spitfire is a value-oriented investor in publicly-traded, smaller capitalization companies. We invest in market share leading businesses which generate excess cash, possess substantial financial flexibility and demonstrate increasing intrinsic value. Our investments offer the potential for significant upside over a one to three year holding period while benefitting from a substantial margin of safety. Most of our targets are underfollowed by sell side analysts and institutional investors and are often attractive acquisition candidates. Since inception, thirteen companies, representing approximately 25% of our investments, have been acquired by strategic or financial buyers.

CURRENT MONTH PERFORMANCE

In January, The Spitfire Fund L.P. was up +3.4% (net), which compares with the Russell 2000 and S&P 500 which were up +6.3% and +5.2%, respectively. Since inception, the Fund is up +85.7% (net), ahead of the Russell 2000 and S&P 500 which are up +16.8% and +12.2%, respectively. In January, markets continued to rally. Our portfolio performed well, with seven positions increasing by over 10%. We are in the midst of earnings season and are taking advantage of this opportunity to recalibrate the investment thesis and risk reward calculus for each of our positions. We have dry powder to take advantage of any market volatility and are researching a number of promising new situations.

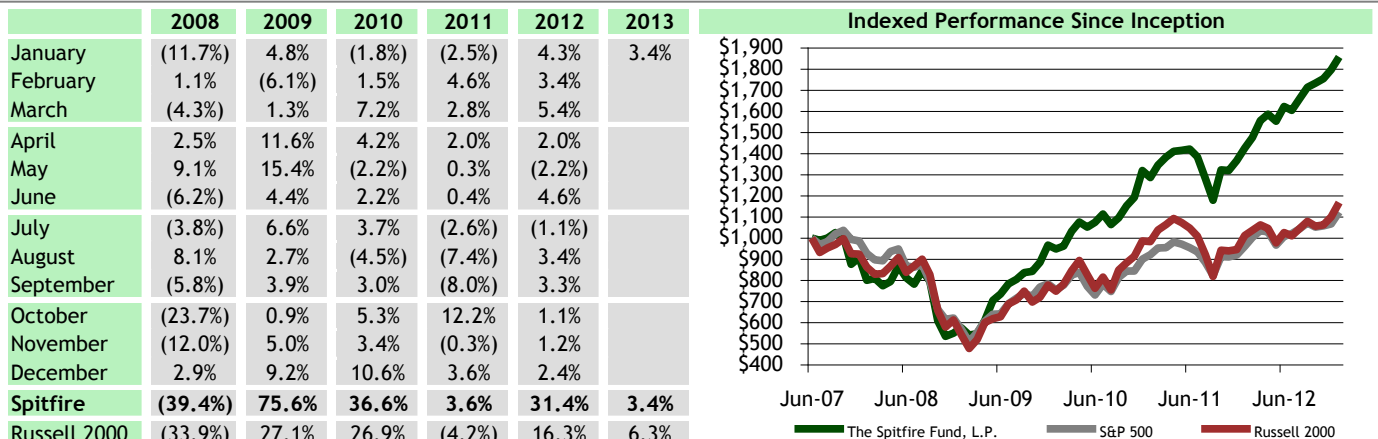
